- Nova Kane spoke to the BIA financials. 2022 City grants were significant which included 'tail end' of COVID-related events grants. With a successful Marda Gras, the year ended in surplus; unrestricted net assets grew to \$185,000.
- Nova talked about the Festival Society and explained that it is currently inactive.

6. 2023 Retrospective and Update

- Bob and Mike B. spoke to key items from the year including:
 - Main Streets construction, how the BIA is trying to mitigate the impact through ongoing marketing and events to keep people coming to the neighbourhood.
 - BIA expansion due to closeness of new business developments and the desire of those businesses to be part of BIA activities.
 - o Martel Block & Harrison projects
 - o Ongoing Marda Loop history project
 - o Ongoing implementation of strategic plan

7. 2024 Look Ahead

- Bob, Mike B. and Nova spoke to:
 - Looking forward to completion of the Main Streets project
 - Further investment in marketing to support businesses during construction then pivot to "grand re-opening."
 - o Major update of strategic plan
 - o Brief mention of "West Elbow" planning process
 - Main streets infrastructure: planters, banners, public art, lighting –
 beautification. Planning and spending by the BIA on some items.

8. 2023 Budget Update

- Nova spoke to:
 - o 20K grant from City for BIA activities to mitigate construction impact.
 - o Marda Gras had a surplus
 - o Investment income better than expected
 - Lower overall streetscape costs due to construction work
 - o Higher costs for insurance
 - Anticipating a small surplus
- Question about BIA levy and budgeted transfer of funds from the reserves. These were discussed to satisfaction.

9. 2024 Budget Planning

- Nova spoke to:
- No changes in the BIA levy amount; not the time given the impact of construction on business; expect individual business "mill rate" to be near 10-year average
- Budgeted pull from accumulated reserves to support increased marketing, streetscape and inflationary costs
- Questions around the levy and how things are budgeted including timing on GIC and interest. These were discussed to satisfaction.
